ARTICLES OF AMENDMENT OF  
ART ON LINE.COM, INC.

THE UNDERSIGNED, WILLIAM K. LOVELACE, being the Vice President and Assistant Secretary, of ART ONLINE.COM, INC., does hereby certify that the following Amendment to the Articles of Incorporation of ART ONLINE.COM, INC. was approved by the Stockholders of said Corporation on the 7th day of July, 2000, at a duly called meeting of the Stockholders and Directors of the Corporation.

1. The Articles of Incorporation of ART ON LINE.COM, INC., are hereby amended as follows:

Article I is hereby deleted and the following is inserted in lieu thereof:

**ARTICLE I**

2. All amendments included herein were adopted pursuant to Section 607.1006, F.S., and there is no discrepancy between the Corporation's Articles of Incorporation as theretofore amended other than the inclusion of these amendments and the omission of matters of historical interest.

4. This Amendment shall be effective upon its filing with the Secretary of State, State of Florida.


