ARTICLES OF INCORPORATION

The undersigned acting as the incorporator of a corporation under the Florida Business Corporation Act, adopts the following articles of incorporation for such corporation:

ARTICLE 1 - CORPORATE NAME

The name of this corporation is SMOAK CONSTRUCTION, INC.

ARTICLE 11 - DURATION

This corporation shall exist perpetually unless dissolved according to Florida law.

ARTICLE 111-PURPOSE

The corporation is organized for the purpose of engaging in the construction repair and remodeling of building and public works of all kinds, for the improvement of real estate, and demolition and any other activities or business permitted under the laws of the United States and the State of Florida.

ARTICLE 1V - CAPITAL STOCK

The corporation is authorized to issue 1000 shares of common stock, par value \$0.50 per share.

ARTICLE V - INITIAL PRINCIPAL OFFICE

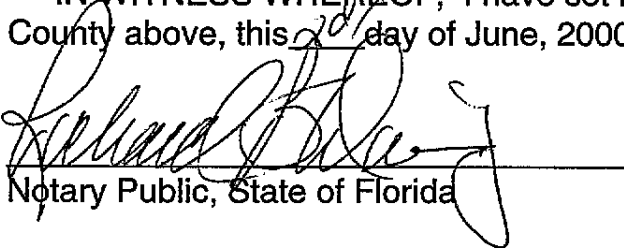

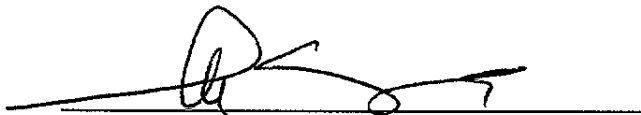
