#### ARTICLES OF INCORPORATION

OF

### MIKSCH & COMPANY, CPA, P.A.

The undersigned, for the purpose of forming a professional corporation in accordance with Chapter 607 of the Florida Statutes and the Florida Professional Service Corporation Act, do hereby adopt the following Articles of Incorporation.

FIRST: The name of the corporation is MIKSCH & COMPANY, CPA, P.A.

<u>SECOND:</u> The corporation shall have perpetual existence.

THIRD: The purpose for which this Corporation is organized shall be to engage in the practice of accounting within the State of Florida, and more particularly to maintain, examine, inspect, and audit the books and accounts of others; to devise and install financial, accounting, checking, correspondence, filing, and other office and business systems; to take inventories; to make appraisals; to prepare financial statements; to compile statistics as an aid to the officers of corporations and other persons in making of reports and statements required by tax laws; to express an opinion in regards to the accuracy of financial statements; to perform all such acts or supply all such services as are commonly performed or supplied by bookkeepers, accountants and management consultants; and to do all things incidental and necessary to the accomplishment of the foregoing purposes.

<u>FOURTH</u>: The professional services of the Corporation shall be rendered only through officers, employees, and agents who are duly licensed or otherwise legally authorized to practice accounting within the State of Florida. Professional services shall be rendered in each case by the officer, employee, or agent designated solely by this Corporation, acting through its duly elected officers. This provision shall not be applicable to the extent it is in conflict with the law or the professional rules of accounting practice.

<u>FIFTH:</u> The corporation is authorized to issue a total of One Thousand (1000) Shares. Such shares shall be of a single class and shall have a par value of One Dollar (\$1.00) per share.

SIXTH: The street address of the initial registered office of the corporation is 4615 Gulf Boulevard, Suite 216, St. Pete Beach, Florida 33706, and the name of the initial registered agent at that address is Diane Miksch.

The address of the principal place of business of the corporation is 4615 Gulf Boulevard, Suite 216, St. Pete Beach, FL 33706.

SEVENTH: The business and affairs of the corporation shall be managed by a Board of Directors, consisting of no less than one (1) person nor more than five (5).
