**ARTICLES OF INCORPORATION
(GENERAL)**

**ARTICLE I
CORPORATE NAME**

The name of the Corporation is South Florida International Legal Service, Inc.

**ARTICLE II
PURPOSE**

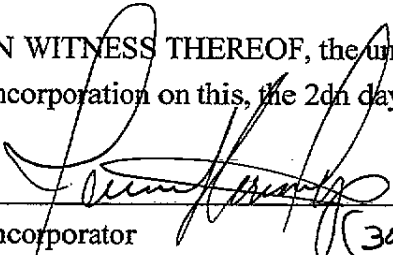
