DURATION

The term of existence of the corporation is perpetual.

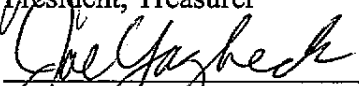
ARTICLE VIII

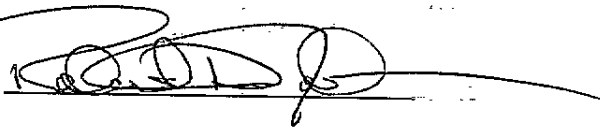
