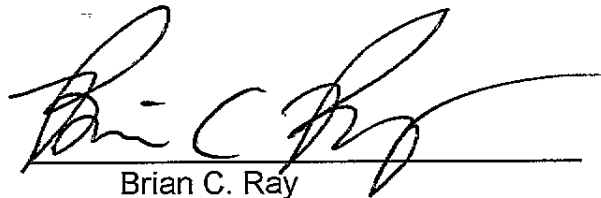

Indemnification

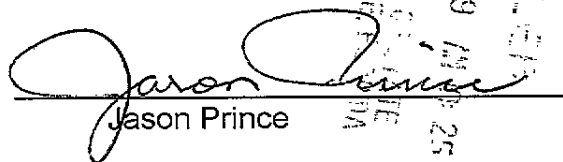
