The undersigned, acting as the sole Incorporator of a Corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such Corporation:

## **ARTICLE I**

### NAME AND ADDRESS

The name of the Corporation is Trident Entertainment Associates, Inc. The address of the Corporation is 10 Tampa Place, Marco Island, Florida 34145.

#### ARTICLE II

#### DURATION
