### ARTICLES OF INCORPORATION OF STEPHENS INSTITUTE, INC.

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the state of Florida.

#### ARTICLE I. NAME

The name of the corporation shall be:
