ARTICLES OF AMENDMENT OF
J. HANDTE PAINTING, INC.

THE UNDERSIGNED, WILLIAM K. LOVELACE, being the Vice President and Assistant Secretary, of J. HANDTE PAINTING, INC., does hereby certify that the following Amendment to the Articles of Incorporation of J. HANDTE PAINTING, INC. was approved by the Stockholders of said Corporation on the 10th day of August, 2000, at a duly called meeting of the Stockholders and Directors of the Corporation.

1. The Articles of Incorporation of J. HANDTE PAINTING, INC., are hereby amended as follows:

Article I is hereby deleted and the following is inserted in lieu thereof:

ARTICLE I

The name of the Corporation shall be ICON FINISHING SYSTEMS, INC.

2. All amendments included herein were adopted pursuant to Section 607.1006, F.S., and there is no discrepancy between the Corporation's Articles of Incorporation as theretofore amended other than the inclusion of these amendments and the omission of matters of historical interest.

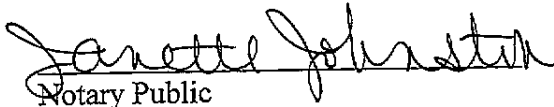
