ARTICLES OF INCORPORATION

OF

GULF ATLANTIC ELECTRICAL CONSTRUCTORS, INC.

ARTICLE I - NAME:

The name of this corporation is: GULF ATLANTIC ELECTRICAL CONSTRUCTORS, INC., hereinafter referred to as the "Corporation".
