ARTICLE I

CORPORATION NAME

The name of this corporation is Beth Fulton Interiors, Inc.

ARTICLE II

PURPOSE

This corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE III

CAPITAL STOCK

This corporation is authorized to issue 1000 shares of common stock.

The common stock of the Corporation shall have the following characteristics: _

- (a) Par value shall be \$1.00 per share
- (b) At all meetings of the stockholders, the common stockholders shall be entitled to cast (1) vote for each share of common stock owned. That a common stockholder is interested in a matter shall not disqualify him from voting thereon.



DATE OF CORPORATE EXISTENCE**

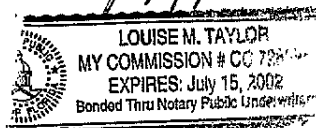
The date the beginning of the corporate existence of Beth Fulton Interiors, Inc., shall be at the time of subscription and acknowledgment of these articles.




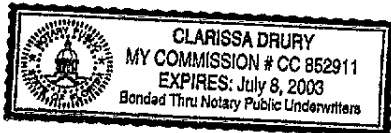
