ARTICLES OF INCORPORATION

OF

Ron Irizarry, Inc.

ARTICLE I. NAME

The name of this Corporation is Ron Irizarry, Inc., and the address is 526 Beasley Court, Orlando, Florida, 32807.

ARTICLE II. TERM OF EXISTENCE

This Corporation shall exist perpetually.

ARTICLE III. NATURE OF BUSINESS

ARTICLE IV. CAPITAL STOCK

No shareholder shall have the preemptive right to purchase any new stock of this Corporation.

No shareholder shall have the right to accumulate his or her votes at any election for the Board of Directors nor any other matter of this Corporation.

ARTICLE VIII. BOARD OF DIRECTORS


