

The corporation shall have all of the corporate powers enumerated in the Florida Business Corporation Act


ARTICLE XI



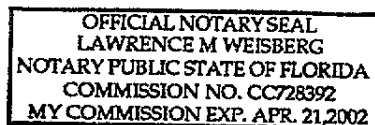
