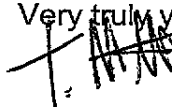

The undersigned, acting as Incorporator(s) of a corporation under the Florida General Corporation Act, adopt(s) the following Articles of Incorporation for such corporation:

1. **Name.** The name of this corporation is BAY AIR CONDITIONING COMPANY, INC.

2. **Principal Place of Business.** The principal place of business of the corporation is 3029 S.W. 28 STREET, MIAMI, FLORIDA.

3. **Duration.** The period of its duration is perpetual.

4. **Purpose.** The purpose is to engage in any activities or business permitted under the laws of the United States and Florida. However, to be more specific it is understood that this business will not engage in the plumbing business and will focus its attention exclusively to air conditioning and/or sheet metal work.
