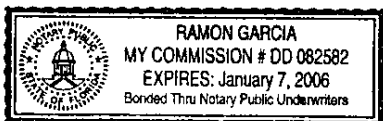

6. No further ground or grounds exist for the administrative dissolution of the Corporation.
