ARTICLE ONE-NAME

The name of the corporation is All Seasons Home and Garden, Inc., whose principal office and mailing address is 646 40th Avenue, Vero Beach, FL 32968.

ARTICLE TWO-PURPOSE

This corporation is organized for the purpose of providing any legal service and goods permitted by the State of Florida.

ARTICLE THREE-CAPITAL STOCK

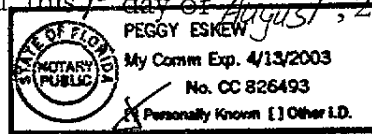
