**ARTICLES OF INCORPORATION
OF

**ARTICLE I

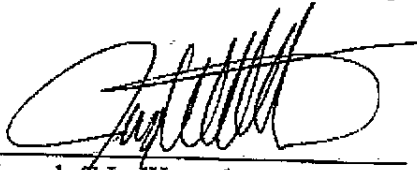
ARTICLE VII

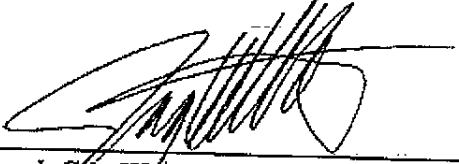
