BY THESE ARTICLES OF INCORPORATION the incorporator forms corporation for profit under Florida law.

1. NAME. The name of this corporation is FINDER'S MEDICAL OF BIRD ROAD, INC.
 2. TERM. This corporation shall exist perpetually.
 3. PURPOSE. The purpose of this corporation is to transact any or all lawful business for which corporations may be incorporated under the laws of the State of Florida.




