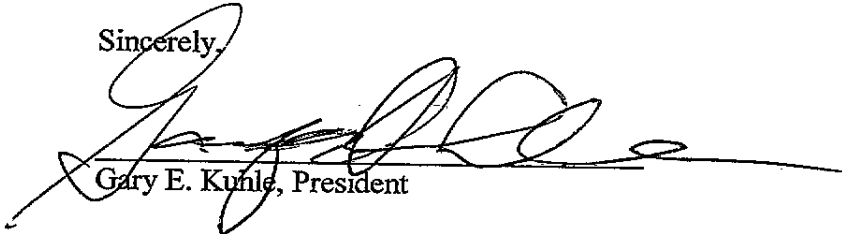

KNOW ALL MEN BY THESE PRESENTS: That the undersigned incorporator does hereby certify that he has formed a body corporate under and by virtue of the laws of the State of Florida for the transaction of business with and under the following charter:

ARTICLE I - Name

The name of the corporation shall be **FLORIDA K-CONSTRUCTION, INC.** with its principal address as Post Office Box 1000, Carrabelle, Florida 32322 .

ARTICLE II - Effective Date

Corporate existence and the right to transact business shall commence upon the filing of these Articles of Incorporation with the Secretary of State..

ARTICLE III - Duration

The corporation shall have perpetual existence, unless terminated in the manner prescribed by the laws of the State of Florida.

ARTICLE IV - Purpose

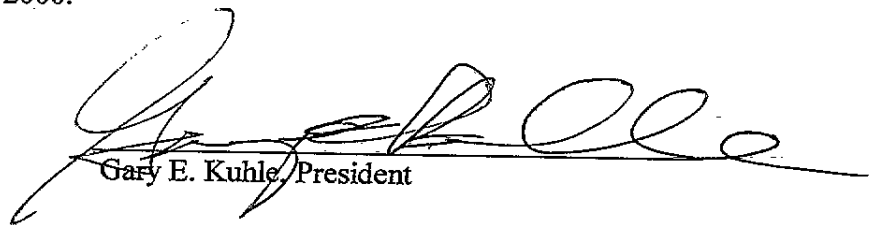
**ARTICLE XIV - Shareholders Not Personally Liable
