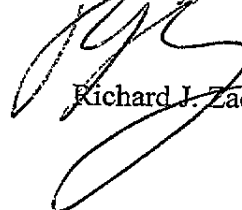

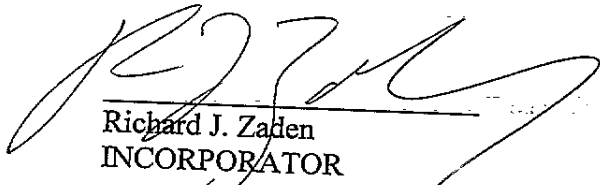

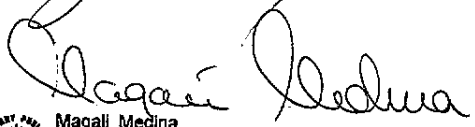
ARTICLE III - AMENDMENTS

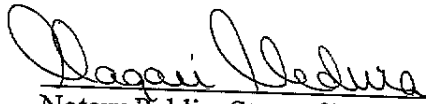

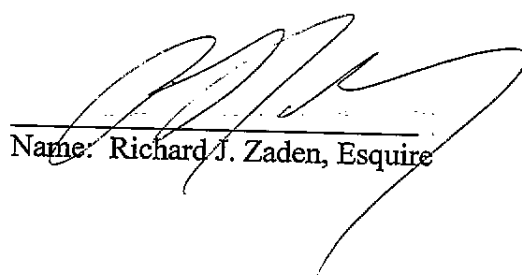
