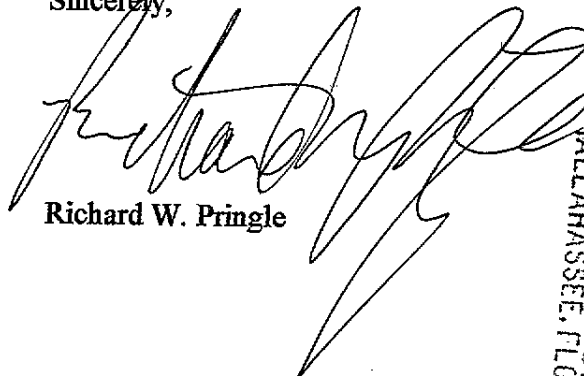

ARTICLE III OTHER ORIGINAL ARTICLES

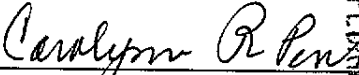
In all other respects, the original articles of incorporation, whose document number is P00000082433, shall remain the same and are hereby readopted and ratified in full.
