The corporation may adopt its by-laws at such time as determined by the Board of Directors

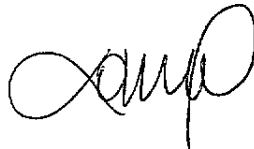
Article 9 – Indemnification
