**ARTICLES OF INCORPORATION  
OF  
FLORIDA KEYS FOOD STORES, INC.**

**THE UNDERSIGNED**, for the purpose of forming a corporation under the Florida General Corporation Act, do(es) hereby adopt the following Articles of Incorporation:

**ARTICLE I:  
NAME OF CORPORATION**

The name of the corporation is **FLORIDA KEYS FOOD STORES, INC.**, and the mailing address is Harbor Drive, Islamorada, Florida 33036.

**ARTICLE II:  
DURATION**

The duration of the corporation is perpetual.

**ARTICLE III:  
PURPOSE**

The general purpose for which the corporation is organized is:

To transact all lawful business for which the corporation may be incorporated under the Florida General Corporation Act, or engage in any other trade or business which can, in the opinion of the Board of Directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.

**ARTICLE IV:  
NUMBER OF SHARES**

The aggregate number of shares which the corporation is authorized to issue is 1,000 shares. Shares are of a single class, and shall have a par value of One Dollar (\$1.00).

**ARTICLE V**

The power to adopt, amend or repeal bylaws shall be vested in the Board of Directors and Shareholders. The Board of Directors may not alter, amend or repeal any bylaws adopted by the Shareholders if the Shareholders provide that the bylaws shall not be altered, amended or repealed by the Board of Directors.

**ARTICLE VI**

The street address of the initial registered office of the corporation is 55 Harbor Drive, Islamorada, Florida 33036, and the name of its resident agent is **GREGORY MCKENZIE**.



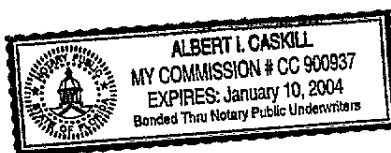


