ARTICLES OF INCORPORATION
OF
EVERSHINE COLUMBIA, INC.

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation is EVERSINE COLUMBIA, INC.
