**ARTICLES OF INCORPORATION  
OF  
ANDERSON TECHNICAL SYSTEMS, INC.**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

**Article 1. Name.** The name of the Corporation is: **Anderson Technical System, Inc.**

**Article 2. Address of principal office.** The address of the principal office and the mailing address of the corporation is 3403 Willow Oak Drive, Edgewater, FL 32141.

**Article 3. Duration.** The duration of the Corporation is perpetual.

**Article 4. Purpose.** The general purposes for which the Corporation is organized are the following:

A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.

B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

C. To engage in heating and air conditioning sales, installation, and maintenance.

**Article 5. Capital Stock.** The aggregate number of shares which the Corporation is authorized to issue is one thousand (1,000) shares of common stock. Such shares shall be of a single class and shall have a par value of \$1.00 per share.

**Article 6. Initial Registered Office and Agent.** The initial Registered Agent is Timothy S. Anderson and the street address of the initial Registered Office of the Corporation is 3403 Willow Oak Drive, Edgewater, FL 32141.

**Article 7. Initial Board of Directors.** The number of Directors constituting the initial Board of Directors is one (1). The number of Directors may be increased or decreased from time to time in accordance with the Bylaws but shall never be less than one. The name and address of each initial Director of the Corporation is as follows:

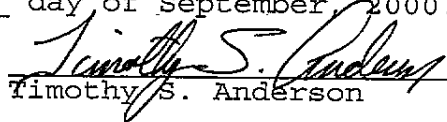
