The undersigned, for the purpose of forming a Professional Service Corporation under the provisions of Chapter 607, Florida General Corporation Act, and Chapter 621 of the Florida Professional Service Corporation Act, of the Florida Statutes, hereby adopts the following Articles of Incorporation.

ARTICLE ONE

DURATION

The duration of the Corporation is perpetual.

ARTICLE THREE

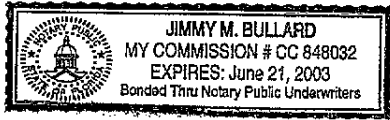
