ARTICLE I

- The name of the Corporation is: ACUPUNCTURE & HOLISTIC ARTS
CENTER, INC.

ARTICLE II

The Corporation may engage or transact in any or all activity
or business permitted under laws of the United States and the State
of Florida. The corporation shall exist perpetually.

ARTICLE III

CAPITAL STOCK

The Corporation is authorized to issue and have outstanding at
any one time an aggregate number of One Hundred (100) shares of
One-Dollar (\$1) par value common stock, which shall be designated
"Common Shares." The consideration to be paid for each share of
stock shall be fixed by the Board of Directors.

ARTICLE IV

CUMULATIVE VOTING

At each election for directors, every holder of the capital
stock (or voting stock, if there is more than one class and one
class is nonvoting) shall have the right to vote, in person or by
proxy, the number of shares registered in his name for as many
persons as there are directors to be elected and for whose election
he has a right to vote, or to cumulate his votes by giving one
candidate as many votes as the number of such directors multiplied
by the number of his shares shall equal, or by distributing such
votes on the same principle among any number of such candidates.
Notice must be given by any shareholder to the President and the
Vice-president of the Corporation, not less than twenty-four (24)
hours prior to the time set for the holding of a shareholders
meeting for the election of directors, that such shareholders
intend to cumulate his vote at said election.

PREEMPTIVE RIGHTS

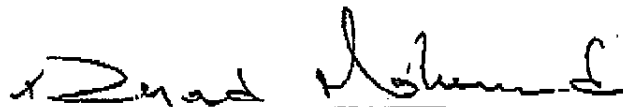
