ARTICLE I  
NAME

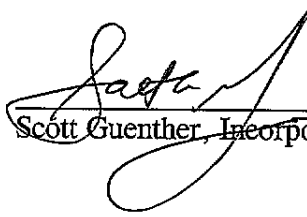

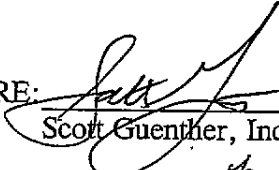

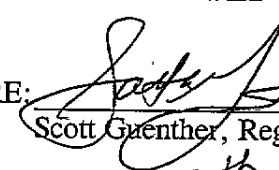
