# SLOWLTARY OF STATE FLORIDA GEODETIC SURVEYING AND MAPPING, INCALLAHASSEE, FLORIDA

The undersigned hereby adopt the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida.

### **ARTICLE I - NAME**

The name of the corporation is Florida Geodetic Surveying and Mapping, Inc. The principal address of the corporation is 720 W. Montrose Street, Clermont, Florida 34711.

# ARTICLE II - COMMENCEMENT AND TERMINATION

The effective date upon which this Corporation shall come into existence shall be the date of filing of these Articles, and it shall exist perpetually thereafter unless dissolved according to law.

#### ARTICLE III - PURPOSE

The corporation is organized for the purpose of land surveying and mapping and transacting any and all lawful activity and business permitted under the laws of the State of Florida and the United States of America.

#### ARTICLE IV - CAPITAL STOCK

The maximum number of shares which the corporation is authorized to have outstanding at any one time is 1,000 shares of common stock. The par value shall be \$1.00 per share, with the consideration to be paid in money, property, or services actually performed, as may be fixed by the Board of Directors.

# ARTICLE VII - RIGHT OF FIRST REFUSAL

No shareholder of this corporation shall have the right to sell or assign stock of the corporation without having first offered to sell such shares first to the corporation and then to other shareholders of the corporation at the same price and on the same terms and conditions pursuant to which the shareholder intends to sell his shares, subject only to this right of first refusal of the corporation and the other shareholders.

Each stock certificate issued representing shares of the corporation shall bear a restrictive legend as follows:

Transfer of this certificate and the shares represented hereby is subject to the right of first refusal of the corporation and the other shareholders contained in the Articles of Incorporation of the corporation to which the holder hereof assents.

#### ARTICLE VIII - LOST OR DESTROYED CERTIFICATES

Stock certificates to replace lost or destroyed certificates shall be issued on such basis and according to such procedures as are from time to time provided for in the By-Laws of the corporation.

#### **ARTICLE IX - AMENDMENT TO ARTICLES**

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the board of directors, proposed by them to the shareholders, and approved at a shareholders meeting by a majority of the stock issued and entitled to be voted, unless all the directors and all the shareholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made. Any right conferred by these Articles of Incorporation upon the shareholders is subject to this reservation.

#### ARTICLE X - BY-LAWS

The power to adopt, alter, amend, or repeal By-Laws of this corporation shall be vested in the board of directors.

## ARTICLE XI - INDEMNIFICATION
