The name of this corporation shall be KimBro Construction, Inc.

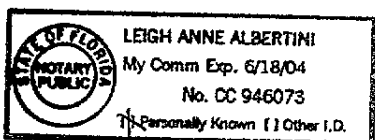


