ARTICLES OF INCORPORATION
OF

Pursuant to Section 607.0202, Florida Statutes, these articles of incorporation provide that:

1. The name of the corporation is **A BETTER METTER, INC.**, (the "Corporation").
2. The principal office of the Corporation is:

3. The aggregate number of shares which the Corporation is authorized to issue is 100 shares of Common Stock, par value \$1.00 per share.
