
**ARTICLE THIRTEEN**

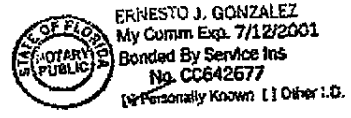
