

ARTICLES OF INCORPORATION
OF
ATLANTIC COAST INSURANCE, INC.

ARTICLE I

The name of this corporation is ATLANTIC COAST INSURANCE, INC.

ARTICLE II

This Corporation shall have perpetual existence, unless sooner dissolved according to law.


