In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of this corporation is ALPHA & OMEGA DEVELOPMENT, INC.

ARTICLE II

The existence of the corporation shall begin on the date in which it is recorded in the Office of the Secretary of State, Division of Corporations.

ARTICLE III

ARTICLE IV

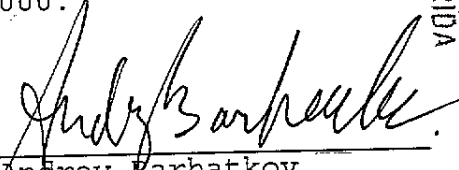

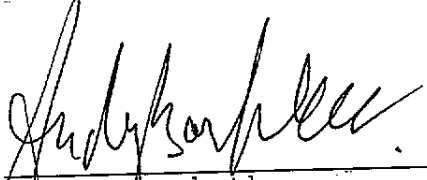
