**ARTICLES OF INCORPORATION
OF
ARGENTINOS, INC.**

THE UNDERSIGNED, acting as Incorporator of Argentinos, Inc., pursuant to the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation is **ARGENTINOS, INC.** (hereinafter called the "Corporation").

ARTICLE II

ARTICLE III

The Corporation is organized to engage in any activity or business permitted under the laws of the United States and the State of Florida.

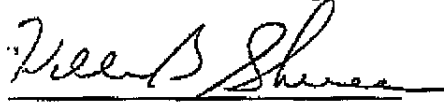
