

**ARTICLES OF INCORPORATION
OF
INTERWEB INFORMATION, INC.**

ARTICLE 1: CORPORATE NAME: The name of this corporation is Interweb Information, Inc.

ARTICLE 2: PRINCIPAL OFFICE: The street address of the initial principal office of this corporation is 5786 Wiles Road # 129, Coral Springs, Florida 33067.

ARTICLE 3: MAILING ADDRESS: The initial mailing address of this corporation is 5786 Wiles Road # 129, Coral Springs, Florida 33067.

ARTICLE 4: CORPORATE POWERS: This corporation shall have the power to engage in all transactions permitted by law, and shall otherwise have all powers and may engage in all business permitted by law.


