The undersigned forms this corporation for profit in accordance with the Florida General Corporation Act.

ARTICLE I - NAME

The name of the corporation is EDDY TOWING & WRECKER SERVICE INC.

ARTICLE II - PRINCIPAL OFFICE

The principal office and mailing address of the corporation is 940 N.W. 35th Avenue, Miami, Florida 33125.

ARTICLE III - DURATION

This corporation shall have perpetual existence commencing on the date these Articles are filed with the Secretary of State.

ARTICLE IV - PURPOSES
