Articles of Incorporation
of

Article I. Name

The name of the corporation is ABC & D Lending of Southwest Florida, Inc.

Article II. Duration

The term of existence of the corporation is perpetual.

Article III. Commencement of Existence

The corporation shall be deemed to commence on December 1, 2000.

Article IV. Principal Office and Mailing Address

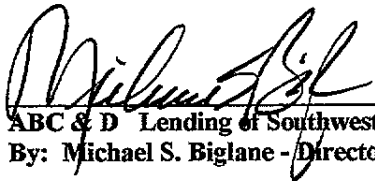

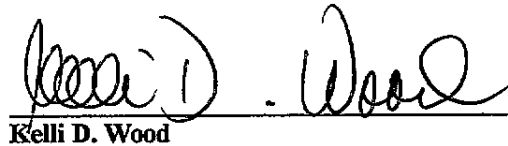
