

The following is a brief review of our Architectural Committee meeting held on June 27TH 2004. The purpose of these meetings, which are held on the last Sunday of every month, are to review any and all plans submitted to us for approval prior to starting any projects such as pools, fences, construction of any time, etc. We review these plans so that our Deed Restrictions and the integrity of our neighborhood is upheld. Along with the review of these plans, we also review reports from our Gate and Grounds Committee on gate performance and updates to our code list, and grounds upkeep in compliance to our Deed Restrictions. Keep in mind that we are representing you as Home Owners and encourage everyone to attend if so desired for your input. Our main purpose after all of our debating boils down to increasing all of our property values as Compass Pointe Homeowners. The following is an outline of our last meeting.

PARKING IN THE STREET is always the # 1 issue from Committee Members and Home Owners at our meetings. We have had several accidents directly related to street parking. We have been told from EMS and Fire Dept. that they will be hampered in response because of the vehicles parked on our streets. This has been brought up at **EVERY** meeting we have had, and is suggested we make this an enforceable violation added to our Deed Restrictions. We will be voting on this in the future. We have concerns about children playing and possibly running into the street between the parked vehicles and getting hit, so please keep all of this in mind.
