ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF QMW ACQUISITION CORP., a Florida corporation



Pursuant to the Florida Business Corporation Act, Article I of the Articles of Incorporation of QMW ACQUISITION CORP., a Florida corporation, hereinafter referred to as the "Corporation", is amended to read as follows:

ARTICLE I Name
