**Name**

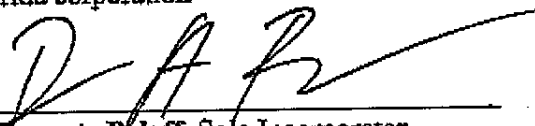
The name of the Corporation is **QMW COMMUNICATIONS, INC.**
