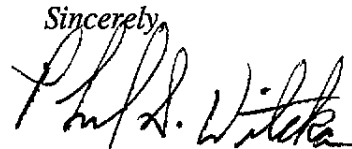

**ARTICLES OF INCORPORATION
OF
LIDDELL ENTERPRISES, INC.**

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I

The name of the corporation shall be:

LIDDELL ENTERPRISES, INC..

The address of the principal office of this corporation shall be 3424 S.W. 42nd Way, Gainesville, Florida 32608.

ARTICLE II

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, or the State of Florida or any other state, country, territory or nation.

ARTICLE III

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 100 shares of common stock having a \$.01 par value per share.

ARTICLE IV
