

OF

The undersigned, acting as incorporator of BIRDIE PAR CORP. under the Florida Business Corporation Act, adopts the following Articles of Incorporation

ARTICLE I. NAME

The name of the corporation is BIRDIE PAR CORP.

ARTICLE II. ADDRESS
