The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of this Corporation is: **Hutchinson Design & Construction, Inc.**

ARTICLE II - ADDRESS OF THE PRINCIPAL OFFICE

Located in Franklin County, the principal place of business and street address of this corporation shall be: **315 Paradise Lane - Apalachicola, Florida 32320** The mailing address shall be: **P.O. Box 306 - Apalachicola, Florida 32329**

ARTICLE III - PURPOSE

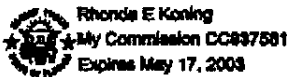
