ARTICLE I

NAME

The name of this Professional Service Corporation is ACADIA NEURO-BEHAVIORAL ASSOCIATES, P.A. (the "Corporation").

ARTICLE II
ADDRESS

The mailing address and principal office of the corporation is 19503 N.W. 57th Avenue, Suite A, Miami, Florida 33055.

ARTICLE III
PURPOSE

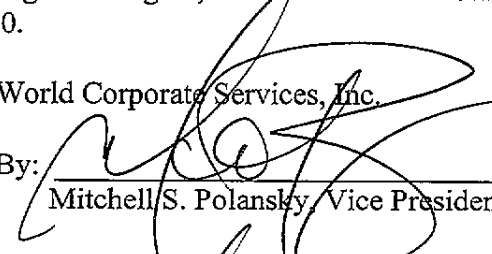

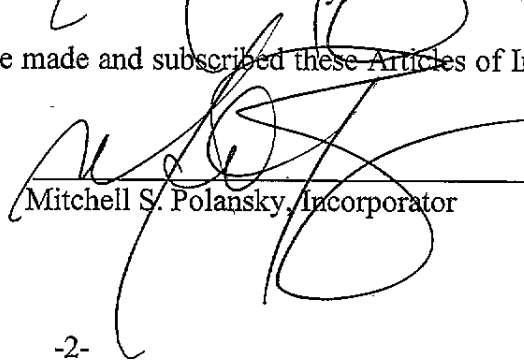
