Articles of Amendment

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, Virtual Innovations, Inc., a Florida corporation, does hereby amend its Second Amended and Restated Articles of Incorporation.

1. The name of the corporation whose Articles of Incorporation are being amended by these Articles of Amendment is Virtual Innovations, Inc.

2. Article I of the Second Amended and Restated Articles of Incorporation of Virtual Innovations, Inc., a Florida corporation, is hereby deleted in its entirety, and the following Article I is hereby inserted in its place:

ARTICLE I

Corporate Name


