**ARTICLES OF INCORPORATION

ARTICLE I – NAME

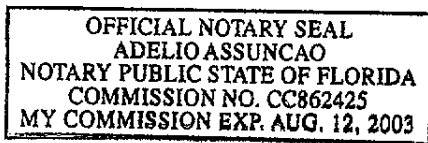
ARTICLE IX – BYLAWS
