NAME

The name of this corporation is RHS Acquisitions Corp.

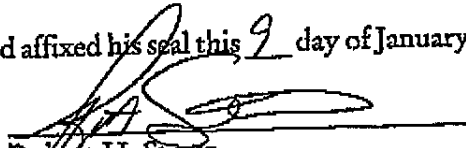

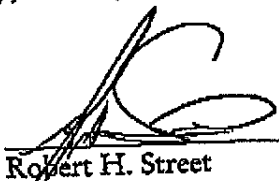
