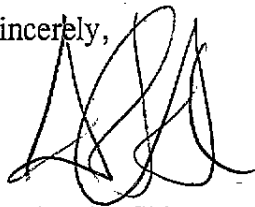

ARTICLES OF INCORPORATION
OF

Pet Paradise Animal Hospital, Inc.

The undersigned Incorporator, being a person competent to contract, subscribes to these Articles of Incorporation to form a Corporation for profit under the laws of the state of Florida.

ARTICLE I - Name

The name of the corporation is **Pet Paradise Animal Hospital, Inc.**

ARTICLE II - Principal Office

The principal office and mailing address of the corporation is **1474 Royal Circle, Apopka, FL 32703.**

ARTICLE III - Capital Stock

The maximum number of shares of stock that the corporation is authorized to issue is **1,000** shares of common stock having par value of **Ten (\$0.10) Cents** per share. The consideration to be paid for each share shall be fixed by the Board of Directors.

ARTICLE IV - Initial Registered Office and Agent

The street address of the initial registered office of this corporation is **1474 Royal Circle, Apopka, FL 32703**, and the name of the initial registered agent of this corporation is **Ana Doris Ortiz.**

ARTICLE V - Incorporator

ARTICLE VI - Directors

The corporation shall initially have **one (1) director**. The method of electing (eg., cumulative, non-cumulative), removing and replacing directors shall be prescribed by the By-Laws of the corporation. The number of directors may be increased or decreased from time to time by the By-Laws of the corporation. The names and street addresses of the initial directors who shall hold office until the first annual meeting of the Stockholders of the corporation or until their successors are elected or appointed and qualified are:

These Articles of incorporation may be amended in such manner as provided in the By-Laws of the corporation.

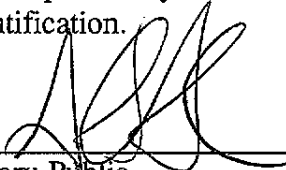
