All costs and expenses of a Director in connection with any such action, suit or proceeding not brought by or in behalf of the Corporation, including by not limited to expenses incurred in the course of attending trials, conferences, depositions, hearings and meetings, shall be paid by the Corporation, and in the event of a judgment or decree being rendered against the Director, the Corporation shall indemnify and save him harmless.

#### REIMBURSEMENT OF DIRECTORS

#### **ARTICLE XV**

#### DIVIDENDS

Provided, however, this restriction shall not apply to the transfer of any stock to a spouse of an existing Stockholder.
